

Charney History Group

Trouble at t' Mill

Newspaper research sheds light on why The Mill seems to have been out of use either side of 1800:

Monday 12 April 1773

Last Thursday Morning, about Eight o'Clock, a terrible Fire happened at the Village of Charney, near Wantage, Berkshire, occasioned by the Carelessness of not putting out Fire that had sin?ed [singed?] a Hog: While the Hog was carrying within Doors, 'tis supposed the Wind, which at that Time was very high, blew some of the lighted Straw about the Farm-Yard, which instantly caught Fire, and the Flames spreading With the greatest Rapidity, the Barns, Stables, and Outhouses belonging to Mr. Dew, were immediately consumed, and all his Stock Corn, &c. with the Dwelling House, Barns, &c. of Mr. John Bunce, a Farmer, together with a Mill upon River Ock. The Fire raged so very furiously, that the unhappy Sufferers could hardly save any Thing. The loss altogether is supposed to amount to 30001.[£3000]

And later:

Saturday 20 April 1782

WATER MILL

TO be LETT, upon reasonable Terms, for the Term of Twenty-one Years, – A Water Course, at Charney, Berks, to build a Corn Mill upon; with a few Acres of Land, if required. – Enquire of Mr Thomas Woodbridge, of Charney; or of the Printer hereof. – The Charney Fishery may be rented by the Miller, if desired.

Resulting in:

Oxford Journal - Saturday 15 August 1807

A substantial new erected WATER CORN MILL, on the River Ock, situate at Charney,

Update From Charney Hall & Field Trust

The Woodland Project

The aspens are down!

Thanks go, in particular, to our health and safety team (Lucy, Neil and Dave Jones) for monitoring the process from start to finish.

The children's play area is open and the hazard tape has been relocated to discourage entry to the woodland work area from the playing field side, whilst allowing free entry to and exit from the

play area itself.

If you see 'smoke' coming off the piles of chippings there is no need for concern as this indicates composting has started. It is hoped stump grinding will be actioned by mid-November and certainly before Christmas. The wood stored on Buckland Road will be removed to the processing plant in November.



Next Steps

The Management Committee is now turning its attention to the formation of a small project team charged with bringing forward and implementing detailed proposals for the development and maintenance of the woodland, which will satisfy the replanting requirements of the Felling Licence and secure the long term future of the area as a woodland.

It is envisaged the team will

- seek specialist advice,
- develop a working map, prepare and implement a replanting plan which conforms with the felling licence,
- · identify short and longer term financial implications and research potential sources of grant aid,
- · consider how the village in general and children in particular can be involved in the project,
- ensure compliance with legal, health and safety and insurance requirements.

The views of the Parish Council are being sought.

The Management Committee is keen to hear from any villager who might be interested in assisting with some or all of this important development.

A Tribute to David Douglas

One of Charney Bassett's oldest sons passed away last month after a long battle with Parkinson's Disease and just a year after Barbara died. He was 85. The youngest of 6 children, he met Barbara in his 20's and they moved to Longmead, on the Gainfield Road, in autumn 1962 when it was a small two-bedroom bungalow. It was here that their three children, Elizabeth, Tony and Andrew were raised. David worked as a radio repairman before moving into TV repairs firstly for Russell Acott of Headington Road, Oxford, then at Norton's TV in Stanford-in-the-Vale and later at Grove TV and Electrical, Millbrook Square. He then started his own business of 'D.Douglas and Sons' with shops at various times in Sunningwell, Lukers Garage (near the church in Charney) and finally operating from his workshop at home. When asked why the 'and Sons' in his business title, he thought 'it looked more professional'.

David's hard work and dedication were also found in his roles outside of work. He was a member of St Peter's Church since 1962, serving as church warden for over three decades. He was an enthusiastic member of the church choir, never shying away from attempting harmonies! He was also a keen cornet player with the Wantage Silver Band; for many years playing Christmas carols with the band on the streets of the Wantage area. When I took him to a band rehearsal a few months back, he was greeted with great affection by many band members there. At considerable emotional cost he used that occasion to donate his cornet to the band. He also got involved in amateur dramatics, mainly to encourage Barbara's acting passion though finding a stage presence of his own. I'm told they appeared in episodes of Midsomer Murders though apparently survived to tell the tale!

Having known him for a mere 25 years, I valued friendship with this lovely man who quietly contributed so much to the life of our village. After his death, a lovely card was received from one of his carers who wrote 'I will miss David because he was a real gentleman' - something many of us will echo.

Neighbourhood Watch Advice on Scams

Be aware of spoof websites

Criminals are sophisticated; creating spoof websites that imitate those of trusted organisations in order to persuade you to enter your personal and financial information.



They'll include the organisation's branding with small changes to the website's URL to convince you it's genuine.

Don't automatically click on links in emails and texts. In stead login to your account directly using a secure webpage or app and if you're visiting a website for the first time, always type the address into the browser.

If you receive a scam email forward it to report@phishing.gov.uk and scam texts to 7726.

Friends against scams: new scam protection website

Anyone can be the victim of a scam, however some people are more vulnerable to scams and criminals will use this to their advantage.



A guide has been prepared by the National Trading Standards Scams Team and the National Centre for Post Qualifying Social Work and Professional Practice at Bournemouth University, working in partnership with Lloyds Bank, Halifax and Bank of Scotland.

So why not take a look at <u>this new guide</u> and help prevent your loved ones being targeted by scams? The aim is to help to manage finances and avoid scams for people at risk and those who support them.

Fireworks safety in Oxfordshire on 5th November

As Bonfire Night approaches, Oxfordshire County Council is reminding residents that the safest way to celebrate is to attend a professionally organised public event that is confirmed as COVID-19 safety compliant, following local and national guidance.

However, as it will not be practical for everyone to attend organised public events, particularly this year, Oxfordshire County Council Fire and Rescue Service is providing guidance for anyone having their own fireworks display:

Top safety tips for Bonfire Night:

- Only buy CE marked fireworks from reputable and licensed shops;
- · Keep fireworks in a closed, metal box;
- · Light the firework at arm's length with a taper and stand well back;
- Keep naked flames, including cigarettes, away from fireworks;
- Don't put fireworks in pockets and never throw them;
- Never return to a firework that has not gone off, and never throw used or unused fireworks onto a bonfire;
- Never drink alcohol while lighting a bonfire or setting off fireworks;
- Always supervise children and don't give sparklers to a child under five;
- Keep your bonfire at least 18 metres away from houses, trees and hedges. There should be a barrier around the bonfire to keep spectators five metres away. Before lighting a bonfire, check it is stable and that there are no children or animals inside;
- Only burn dry wood, never use paraffin or petrol on a bonfire and think about the direction of smoke travel;
- · Keep some buckets of water nearby;
- Have consideration for those around you, including notifying neighbours who may have pets or farm animals:
- Consider where fireworks and debris might fall, ensuring safety distances are provided for people to keep safe. Safety distances are provided on each firework label or package.

Pete Mackay, Community Safety Manager from Oxfordshire County Council Fire and Rescue Service, said:

"Organised fireworks displays are more fun, cheaper and far safer than hosting your own fireworks or bonfire party, but we know there aren't as many to attend safely this year. If you are planning on using fireworks for a private event, please keep the Fireworks Safety Code in mind: www.saferfireworks.com/ as well as following the local and national COVID-19 guidance. Remember, only buy fireworks from a reputable retailer. Before purchasing, seek advice on the suitability of fireworks for the space available, and check that they meet current safety standards."

To reinforce this safety-first approach, the County Council's Trading Standards team (tel: 01865 895999) will be inspecting all firework premises to give businesses advice on the responsible sale and storage of fireworks; checking they meet the necessary safety standards.

Anyone with concerns that retailers are not storing fireworks appropriately, selling fireworks that do not display a CE mark, or selling to anyone under 18; contact Trading Standards. They can also provide safety advice on disposing of unused or damaged fireworks. Do not put fireworks into your bin.

Registered and wraparound childcare open. Supervised activities permitted in private homes. Children's groups permitted.

Youth Clubs and Activities



Permitted.

Cover face wear a face covering in enclosed spaces

Remember brown bin customers can put out twice as much garden waste (in a bag or box) on Monday, 9th November.


