1. Chair welcomed everyone to the meeting.
2. Christine Trotman was appointed secretary for the meeting.
3. Minutes of AGM held 5th June 2019 were proposed for approval by Lucy Gildersleeves seconded by Diane Ewart and passed unanimously and signed as a true record by the chair.
4. Matter arising from Minutes of AGM held 5th June 2019.
 - a. Dog waste bin not yet in place until it is possible to demonstrate to the VWHDC that there is a need for one. Chair thanked Mary Castle for her time in pursuing this issue and to Bruce Royan for his efforts in clearing dog waste from the field.
 - b. The setting up of a focus team to run the hall and field has been a great success. Shadowing of lead trustees to be explored in the future.
5. Annual report of Trustees
 - a. Chair highlighted the following
 - i. The work on health and safety on field and in the hall.
 - ii. The Woodland project.
 - iii. The Memorandum of Understanding (MOU) with Parish Council around responsibilities for areas of the field.
 - iv. The play area is now open following closure due to the pandemic.
 - v. Trustees working hard to put in place safety measures in the hall ready for opening again in the Autumn.
 - b. Chair extended special thanks to Peter Busby for all his work on the MOU and woodland project and to Bruce Royan for his work on the field.
 - c. Treasurer added that since the report had been written CHAFT had received a Retail, Hospitality and Leisure Grant of £10000 to assist with the loss of income and for paying for the measures needed to make the hall as safe as possible with regard to

Covid-19. Treasurer explained that an early poll of regular users shows a reluctance to return and that CHAFT should expect its income in 2020/21 be greatly reduced with the only significant contribution coming from the 100 Club.

6. No public questions had been received on email or verbally in advance of the meeting.

 - a. the History Group has expressed a wish to be included in the list of groups eligible to have a representative on the CHAFT management Committee.
